Ammunition: Recommended 2 bricks/1,000 rounds. .22 LR Standard velocity.

Ammo will be available for sale at the camp.

Pellets are available at \$12/container/500 pellets

- Lodging: **Because of liability issues, there will be no On-site RVs or camping.**
- Transportation: To and from the motel is each shooter's responsibility.
- Meals: Lunch and snacks will be provided each day to registered shooters. Lunch is available for those not registered for a donation. Breakfast and dinner are NOT provided. There are a number of nearby options.
- Arrival: Check-in is from 8:00 am-9:00 am Saturday, May 27th at the upper range. Four Corners Rod and Gun Club 7695 Babcock SE, 3 miles East of Lancaster Drive on State Street, right on 74th St.
